

# PRIVACY POLICY

**Publisher Privacy Policy Effective Date: February 28, 2026**

**Indie Remix Studios** (“we,” “us,” or “our”) respects your privacy. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you play our games, visit our websites, or use our services (collectively, the “Services”).

## 1. Information We Collect

- **Account & Profile Data:** username, email, password, profile picture, linked social accounts.
- **Gameplay Data:** in-game actions, progress, scores, achievements, playtime, crash reports.
- **Device & Technical Data:** IP address, device ID, hardware model, OS version, browser type.
- **Purchase & Payment Data:** billing address, transaction ID (we do not store full credit card numbers).
- **Marketing & Analytics Data:** cookies, pixels, Google Analytics, Unity Analytics, Facebook pixels, etc.
- **Children’s Data:** If you are under 13 (or 16 in some jurisdictions), we comply with COPPA and do not knowingly collect personal information without verifiable parental consent.

## 2. How We Use Your Information

- To provide, maintain, and improve the Services.
- To process purchases and manage accounts.
- For analytics, personalization, and anti-cheat measures.
- To send you updates, newsletters, and promotional offers (you can opt out).
- To comply with legal obligations and enforce our EULA.

## 3. Sharing Your Information We may share data with:

- Service providers (hosting, analytics, payment processors, cloud services).
- Advertising partners (only non-personal identifiers unless you consent).
- Law enforcement or regulators when required. We do **not** sell your personal data.

**4. Cookies and Tracking Technologies** We use cookies, web beacons, and similar technologies. You can manage cookie preferences through your browser or in-game settings.

**5. Data Security** We use reasonable administrative, technical, and physical safeguards. No method is 100% secure.

#### **6. Your Rights**

- Access, correct, or delete your data (subject to legal limitations).
- Opt out of marketing emails (unsubscribe link).

**7. Children’s Privacy (COPPA)** We do not knowingly collect personal information from children under 13 without verifiable parental consent. If we become aware we have collected such data, we will delete it.

**8. International Transfers** Your data may be transferred to and processed in the United States or other countries.

**9. Changes to This Policy** We may update this policy. We will notify you of material changes.

#### **END USER LICENSE AGREEMENT (EULA)**

**End User License Agreement Effective Date: February 28, 2026**

This End User License Agreement (“EULA”) is a binding legal agreement between you (“User” or “you”) and **Indie Remix Studios** (“Publisher,” “we,” or “us”) regarding your use of our video games and related services (the “Game(s)").

**1. Acceptance** By installing, launching, or playing any Game, you agree to be bound by this EULA. If you do not agree, do not install or play the Game.

**2. Limited License Grant** We grant you a **personal, non-exclusive, non-transferable, revocable, limited license** to install and use the Game on your personal devices solely for your own entertainment. This license does **not** include ownership of the Game.

**3. Ownership** The Game and all content (art, music, code, characters, etc.) are owned by us or our licensors and protected by copyright, trademark, and other intellectual property laws. You have no ownership rights.

**4. Restrictions** You may **not**:

- Copy, modify, reverse engineer, decompile, or create derivative works.
- Cheat, hack, or use third-party software to gain unfair advantage.
- Sell, rent, lease, or commercially exploit any part of the Game.
- Remove copyright notices.
- Use the Game for any unlawful purpose.

**5. User-Generated Content** If the Game allows you to create content, you grant us a perpetual, royalty-free, worldwide license to use it. You represent that your content does not infringe third-party rights.

**6. In-Game Purchases & Virtual Items** All purchases are final. Virtual items have **no cash value** and are licensed, not owned.

**7. Termination** We may terminate your license at any time if you breach this EULA. Upon termination, you must cease all use and delete the Game.

**8. Disclaimers** THE GAME IS PROVIDED "AS IS." WE DISCLAIM ALL WARRANTIES, EXPRESS OR IMPLIED, INCLUDING MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. WE DO NOT WARRANT THAT THE GAME WILL BE UNINTERRUPTED OR ERROR-FREE.

**9. Limitation of Liability** IN NO EVENT SHALL WE BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, OR PUNITIVE DAMAGES. OUR TOTAL LIABILITY SHALL NOT EXCEED THE AMOUNT YOU PAID FOR THE GAME IN THE LAST TWELVE MONTHS.

**10. Governing Law** This EULA shall be governed by the laws of the State of Arizona, USA, without regard to conflict of laws principles. Any disputes shall be resolved exclusively in the state or federal courts located in Pima County, Arizona.

**11. Changes** We may update this EULA. Continued use after changes constitutes acceptance.
